



## 2017 Custom Energy Efficiency Program Colorado

### Eligibility Assessment Form (EAF)

Atmos Energy offers an Eligibility Assessment to customers who are interested in the installation of energy-efficiency upgrades to their facility. The Eligibility Assessment will determine eligibility for Technical Study and/or Implementation / Installation financial incentives offered by Atmos Energy.

#### Eligibility Assessment Process

**Step 1 – Submit completed EAF to [custom@mesapointenergy.com](mailto:custom@mesapointenergy.com).**

Once received, the Program Administrator will review the application. This may include a phone interview and/or a brief on-site walkthrough depending on the complexity of the facility. The review will determine eligibility for Technical Study and/or Implementation / Installation financial incentives.

**Step 2 – If eligible, apply for Technical Study and/or Implementation/Installation financial incentives.**

The Program Administrator will email findings from the Eligibility Assessment review. If eligible, the customer next fills out an application for the Technical Study or Implementation / Installation Incentive.

**Atmos Energy Custom Energy-Efficiency Financial Incentive Program is available January 1 through December 31, 2017 or until funding is fully allocated.**
